

**Halifax County Electoral Board  
September 6, 2022**

The Halifax County Electoral Board met on September 6, 2022 in the Registrar's office in Halifax, Virginia. The meeting was called to order at 10:00 a.m. by the Chair, Paul Smith, with all members present. The chair called for the minutes from the previous meeting. The minutes from the previous meeting were read and approved. Harry Jones motioned to accept the minutes as read, and Paul Smith seconded. The motion passed. Next on the agenda were public comments regarding Sunday voting. Those present to comment were:

Vice Chair Harry Jones motioned to close the public comment on said names, and the Chair, Paul Smith seconded. The motion passed. The chair called for old business, there was none. The chair called for new business. The Registrar, Heather Harding commented on acceptable ID's for voting and Review of Notice of Election, and Notice of Redistricting. The Registrar also stated that Mr. Frank Carr from American Legion Post 99, met with her regarding a fee for use of the building for the Sinai Precinct during the elections. After further discussion from the board, a motion was made by Harry Jones to accept the proposal from Mr. Carr and Paul Smith seconded. The motion passed. Next the board discussed the Sunday voting hours. Vice Chair Harry Jones motioned that the Board open the floor for discussion on Sunday voting. Ellen Kent seconded, the motion passed. The Chair, Paul Smith stated that there were 45 days for early voting and the last 2 Saturdays before the election were open for voting. Ellen Kent stated she was concerned for older citizens who did not have transportation during the week and Sundays would be a prime time for them to vote since they would already be out for church. Harry Jones stated he had mixed emotions on the Sunday voting. The Board held a vote on whether to have Sunday voting. Paul Smith voted no, Ellen Kent voted yes, and Harry Jones abstained. The vote failed and Harry Jones motioned to revisit the vote at the September 20<sup>th</sup> meeting. Ellen Kent seconded, the motion passed. The Registrar stated that she needed the list of officers of election workers from the Electoral Board by the next meeting on September 20, 2022. With no more new business to discuss, Vice Chair Harry Jones motioned to adjourn the meeting, and Chairman Paul Smith seconded. The meeting was adjourned at 10:50 a.m.
