 All licenses with gross receipts over \$200,000 should be filed by March 15 in order for the Treasurer to bill.

B P O L TAX

RETAIL SALES - \$50.00 plus \$0.14 per hundred dollars of gross receipts in excess of \$200,000.

WHOLESALE SALES - \$50.00 plus \$0.03 per hundred dollars of gross receipts in excess of \$200,000.

CONTRACTOR - \$50.00 plus \$0.11 per hundred dollars of gross receipts in excess of \$200,000.

FINANCIAL & PROFESSIONAL SERVICES - \$50.00 plus \$0.39 per hundred dollars of gross receipts in excess of \$200,000.

REPAIR, PERSONAL AND BUSINESS SERVICES - \$50.00 plus \$0.24 per hundred dollars of gross receipts in excess of \$200,000.

COMMISSION MERCHANT - \$50.00 plus \$0.36 per hundred dollars of gross receipts in excess of \$200,000.

ITINERANT MERCHANT & PEDDLERS - \$500 per year.

COIN OPERATED AMUSEMENT MACHINES - \$100.00 per year license tax. In addition, gross receipts from the machines considered retail sales and are taxed as such.

SPEEDWAYS - \$1,000.00 annually.

CARNIVALS/AMUSEMENTS - \$250.00 a day.

VIR - \$100.00 per event.

REAL ESTATE AGENTS, BROKERS & APPRAISERS - \$50.00 plus \$0.39 per hundred dollars of gross receipts in excess of \$200,000.
