ORDINANCE NO. 2023-25

AN ORDINANCE AUTHORIZING THE PAYMENT OF MONETARY BONUSES TO 911 DISPATCH EMPLOYEES OF HALIFAX COUNTY

WHEREAS, the Virginia Department of Emergency Management, Virginia 911 Services Board of the Commonwealth of Virginia has awarded \$48,750 of grant funds to Halifax County to pay monetary bonuses to full-time and part-time 911 Dispatch employees of Halifax County; and

WHEREAS, the Halifax County Board of Supervisors desires to utilize these available grant funds to pay monetary bonuses to the approximately 19 full-time employees and 1 part-time employee of Halifax County 911 Dispatch; and

WHEREAS, Virginia Code § 15.2-1508 allows a governing body to pay monetary bonuses upon the adoption of an ordinance; and

WHEREAS, this Ordinance has been advertised as required by Virginia Code § 15.2-1427(F).

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF HALIFAX, VIRGINIA as follows:

The Halifax County Board of Supervisors ("Board") hereby authorizes the payment of monetary bonuses to the employees of Halifax County 911 Dispatch in an amount of up to \$2,322.00 per full-time employee and \$1,161.00 per part-time employee, which bonuses including FICA are to total no more than \$48,750. Halifax County 911 Dispatch employees of record as of December 31, 2023 shall be eligible for the bonuses to be paid in the January, 2024 payroll cycle.

This Ordinance shall take effect immediately. ADOPTED this 6th day of November, 2023.
